### Length of list discussion for the Prohibited Eradicate category - Monika

The "prohibited eradicate noxious weeds" category includes noxious weeds that must be eradicated on all lands within the state. Transportation of the propagating parts of prohibited-eradicate noxious weeds is prohibited except as allowed under section <u>18.82</u>. Prohibited eradicate noxious weeds may not be sold or propagated in Minnesota.
